Note that including dating relationship may not be appropriate in all cultures, for example because it may not be appropriate to ask questions on sex to non-married women, or because the nature of engagements may be such that the woman is never spending time alone with her future husband until she is married. Partnership questions may need to be adapted for the country's specific situation. In general same-sex relationships are not included here. Some countries may decide to adapt the questionnaire for same-sex partner violence and include a question on the sex of the partner.

^{iv} The questions on acts of emotional abuse and controlling behaviours (from the WHO instrument) is out of scope of the TOR (i.e. not addressing the current set of indicators) but provides a good introduction to subsequent questions, ensures a gradual build up and aids in establishing rapport between interviewer and respondent. Including this question has additional advantage that it these questions collect information on other manifestations of violence (in relationships), -- in this case emotional violence – which is currently not included in the set of indicators. However, it is foreseen that in the near future a fuller spectrum of indicators on violence against women is achieved (point 35 in report of Friends of the Chair). Adding questions to this respect may be part of ongoing methodological development.

^v One question on economic violence has been added on advice of EGM. **This question will need to be developed further to capture more aspects of economic violence.**

^{vi} Column D answer options have been modified compared to the WHO questionnaire to enable them being asked from all women who report the act (in the WHO questionnaire column D was only asked if the act had NOT occurred in the past 12 months).

^{vii} A more detailed question on frequency has been added for physical and sexual violence in past 12 months to test whether this information can be easily collected.

^{viii} This question is being asked for those who reported physical or sexual violence. From the WHO experience we learned that we miss out on injuries if asked for physical violence only. The questions are phrased differently of WHO questionnaire. In this module, instead of asking first whether she was ever injured, there are direct questions giving examples of injuries. Severity of physical violence could be operationalized by nature of the acts (c-f) as well as by injuries. Need to decide if (for the calculation of the indicator) we also include those who report injuries for only sexual violence without including physical violence.

It should be realized that one case of victimization can have several acts and that in case of repeated victimization one severe incident raises the overall severity of all victimizations.

^{ix} Self perceived impact of partner violence on physical and mental wellbeing is a measure of her subjective experience of the severity of the violence the respondent is living (modified from WHO questionnaire where the question is in the coping section, Section 9) – The way the module has been set up is to only ask this from women who report physical or sexual partner violence (because it refers to the violent acts).

^x The question (not in the WHO instrument) addresses whether the woman is living in constant fear (an alternative question could be 'fearing for her life'), which is a measure of her subjective experience of the severity of the violence she is living. The way the module has been set up is to ask this from all partner women, whether reporting acts of physical or sexual violence or not.

^{xi} Suggested approach has main focus on perpetrators and secondary focus on specific acts (with a question of injuries to operationalize severity). Alternatively one could focus on acts, followed by a question on perpetrators, which (in examples that I

saw), risks losing out on linking specific acts with perpetrators. A modification compared to the WHO questionnaire is to ask first for the period since age 15 followed by the past 12 months, to be able to address the indicators.

^{xii} This question includes more acts compared to WHO questionnaire. This is to ensure including the same acts as for partner violence (even if we are not asking them one by one for reasons of length of the module).

^{xiii} List of perpetrators for non-partner modified compared to WHO instrument.

^{xiv} In the WHO questionnaire there was no question on injuries for non-partners. Note that for non-partners now it is asked for physical violence only (for the severity classification). If there are more than 3 different perpetrators the question will be asked for 3 only.

^{xv} In the WHO questionnaire there is only one question on sexual violence after age 15. For the module there are two: one for rape (unwanted and forced sexual intercourse) and another for all other unwanted sexual acts.

^{xvi} Countries may include one question on forms of violence against women that are important in their context but that are not covered by the module, such as FGM.

^{xvii} Only one woman per household can be interviewed. The way this will be done depends on sampling strategy and vehicle survey. The household selection presented here is an example of a possible way to select one eligible woman in a household (as used in the WHO multi-country study) . It does not form part of the module.

^{xviii} These selection criteria for whom belongs to the 'household' (including live-in domestic workers and long term visitors – as used in the WHO study) may not be feasible for surveys on other subjects.

^{xix} Random selection could be done by this or any other method such as first birth date or Kish table.

^{xx} Whether the interview ends here or not depends on the purpose of the vehicle survey.
